#### Expected Topics to be Covered

- Identify specific components of an Accident Prevention Plan
  - What supporting documentation is required?
    - e.g. Competent Person Resumes
    - How to write an Activity Hazard Analysis
  - Identify specific mandatory training/certifications
    - Safety & Health Inspections
  - Accident reporting/Exposure data (man-hours worked) procedures
- Medical support requirements & other Plans/Programs/Procedures required by EM-385-1-1 Safety & Health Requirements Manual.
  - Review the Accident Prevention Plan Checklist
- How to avoid the top 10 areas most commonly missed in Accident Prevention Plans
